As you know, the MSHA fees are for a calendar year. Once again, the annual statements are being mailed later in the year instead of in January. We plan to resume the January mailing next year. The enclosed statement is for calendar 2000, and is due when received. Thanks for bearing with me and for your cooperation. Some items of interest follow:

#### **Account Audit**

It appears that we will need to do an annual comparison of our files to the Macon County records. Many changes were noted, and I have included notes with the statements where appropriate. PLEASE tell us when you buy, sell or move. Torrey Johnson has performed much of the auditing work again. Thanks, Torrey.

#### Roads

Jim Solesbee continues doing an excellent job of maintaining our roads with his grader. He is also doing the mowing and landscaping work, and we are looking better than ever. The meadow is starting to look like a real park.

We have repaved about one-fourth of the blacktop. The Whispering Springs Homeowner's Association donated \$1,000.00 toward this work as their annual contribution to maintaining the roads that we use in common. We owe thanks to them for sharing the expenses.

#### Water System

The water system continues to be reliable. We have hired a new operator, Bill Bateman, and our water has passed all tests. We sent a water quality report to all members with water rights in July to document our progress, and plan to do this on an annual basis. Let me know if you need a copy.

The engineers have completed the plans for the new tank and the state has given us approval to proceed. We are waiting for a quote for the slab to start construction. Some of the new pipe and fittings are on order, and trenching and foundation work should start soon.

#### **Annual Meeting**

The 2000 Annual Meeting will be in El-Shaddai. The 1999 meeting in, held in Jim and Cookie Godsey's new home in El-Shaddai, was an outstanding success. The 2000 meeting will be held in the Nantahala Community Center starting at 2:00 PM on Saturday, October 21. We plan to have another potluck meal, so bring your appetite. # Minutes -- 2000 Annual Meeting

#### Call to Order

The meeting, held at the Nantahala Community Center, Community Circle, Nantahala Township, Macon County, North Carolina, was called to order by President Torrey Johnson on Saturday, October 21, 2000, at 2:10 p.m.

#### Attendance/Proxies

A total of 17 voting members were present and proxies representing a quorum were received.

## Reports by Officers

Chair suggesting dispensing with reading of 1999 minutes. Motion made to dispense. Motion carried.

Finance report presented by Roger Mays, Treasurer. Motion to approve as read. There was some discussion about the US Forest Service fee for right of way. Motion to approve finance report carried.

Torrey Johnson thanked the Godseys for hosting the dinner and for arranging for the meeting room.

# Road Maintenance

No problems or exceptional road items were reported. The Whispering Springs Homeowner's Association has continued to contribute to the "Main Street" maintenance. This year's contribution of \$1,000.00 was added to \$500.00 of our funds to repave a section of asphalt on Rhododendron Drive.

# Water System

Work continues on the planned improvements to the water system. No major problems were reported. Collections on fees and on the special assessment are proceeding well. Bob Liniger stated that the budget of \$25,000 for the complete job might not cover the total project.

# By Law Modifications

Torrey Johnson presented the revised bylaws and highlighted the major changes. Jimmy Godsey moved that the new bylaws be accepted. Tom McLean seconded the motion. It was passed with no further discussion.

## Road Sharing

The members decided that we would not share roads with our neighbors unless each proposed sharing situation is presented to the members for approval.

## **New Business**

# Water Operator

Bob Liniger said that he had completed training as a C-Well operator and had obtained a state license. He offered to be the official water operator for the same fee we have been paying -- \$150.00 a month. He said the he would check the operation an average of 5 days per week instead of 1 or 2 days per month. Tom McLean moved, Sue Johnson seconded, and the members passed this motion.

## Water System

There was substantial discussion concerning the future plans for the water system. We are permitted for 25 connections, but not fully state approved. We have 56 participating lots and more possible, so the system must be expanded over time.

It was moved and passed that a moratorium on accepting applications for water rights be in effect until the directors determined that further expansion would be proper.

Tom McLean and Bob Liniger are to set up a committee to determine what is both legal and fair for water rights and are to establish preliminary cost estimates for future water system development. They will present their findings at the 2001 meeting.

#### Fees for 2001

It was moved and voted that fees remain unchanged for 2001.
